To Whom it may concern

The Societies Registration Act 1860 (Act No. 21 of 1860) is a Central Act, applicable to all States in India. A Society registered under the provisions of the said Act, in any State, is deemed to be a juristic body, competent to operate, function and carry on its business activities, both in the State where it is registered, and also in any other State in India, in accordance with its Memorandum of Association / Rules and Regulations; in the same manner as a Company incorporated under the Companies Act in a State, may function and carry on its business activities throughout India.

In view of the above position, there is no legal impediment for the Dayanand Anglo Vedic College Trust and Management Society, Chitra Gupta Road, New Delhi, originally registered as a Society under the Societies Registration Act, 1860 to function and carry on its activities anywhere, in any State (s) in India.
